

**SOUTH GLOUCESTERSHIRE COUNCIL**  
**(Various Roads - Bradley Stoke Way Area, Bradley Stoke) (Temporary Prohibition of Use by Vehicles) Order 2026**

Notice is hereby given that South Gloucestershire District Council in pursuance of the provisions of section 14 of the Road Traffic Regulation Act 1984 as amended have made an order the effect of which has closed, temporarily, to vehicles temporarily, to vehicles lengths of road specified in column 1 of Schedule 1 to this notice. This order was required for the following reason: in connection with CRSTS Active Travel works.

The order became operative from 9 January 2026 for a maximum period of eighteen months. The closures however may not be implemented for the whole of the period but only when traffic signs are in position and only for so long as is necessitated by the works. It is anticipated that the works at each location will be carried out between 8pm and 6am on the dates specified in column 2 of the said Schedule. See Schedule 2 for **alternative routes**.

**SCHEDULE 1**

1. **Fidlers Wood Lane**, Bradley Stoke – that length which extends from its junction with Savages Wood Roundabout in an easterly direction for a distance of 100 metres
2. **Savages Wood Road**, Bradley Stoke – that length which extends from its junction with Savages Wood roundabout to its junction with Three Brooks Lane
3. **Brook Way**, Bradley Stoke – that length which extends from its junction with the Patchway Brook roundabout in a southerly direction for a distance of 100 metres
4. **Pear Tree Road**, Bradley Stoke – that length which extends from its junction with the Patchway Brook roundabout in a northerly direction for a distance of 100 metres
5. **Bowsland Way**, Bradley Stoke – that length which extends from its junction with the Patchway Brook roundabout in a north easterly direction for a distance of 100 metres
