

SOUTH GLOUCESTERSHIRE COUNCIL
(Various Roads - Bradley Stoke Way Area - Uni-Directional, Bradley Stoke)
(Temporary Prohibition of Use by Vehicles, Foot Passengers, Pedal Cycles and
Equestrians) Order 2026

Notice is hereby given that South Gloucestershire District Council in pursuance of the provisions of section 14 of the Road Traffic Regulation Act 1984 as amended have made an order the effect of which has closed, temporarily, to vehicles, foot passengers, pedal cycles and equestrians the lengths of road specified in column 1 of Schedule 1 to this notice.

This order was required for the following reason: in connection with the likelihood of danger to the public consequent upon CRSTS Active Travel works on or adjacent to the highway. The order became operative from 9 January 2026 for a maximum period of eighteen months. The closure however may not be implemented for the whole of the period but only when traffic signs are in position and only for so long as is necessitated by the works. It is anticipated that the works at each location will be carried out on the dates specified in column 2 of the said Schedule. See Schedule 2 for **alternative routes**.

| 5. Pear Tree Road , Bradley Stoke – that length of the northbound carriageway which extends from its junction with the Patchway Brook Roundabout in a northerly direction for a distance of 100 metres | 27 April – 21 June 2026 |
| 6. Pear Tree Road , Bradley Stoke – that length of the southbound carriageway that extends from a point 100 metres north of Patchway Brook Roundabout to its junction with Patchway Brook Roundabout | 22 June – 16 August 2026 |
| 7. Brook Way , Bradley Stoke – that length of the northbound carriageway that extends from a point 100 metres south of Patchway Brook Roundabout to its junction with Patchway Brook Roundabout | 20 July – 27 September 2026 |
| 8. Brook Way , Bradley Stoke – that length of the southbound carriageway that extends from its junction with Patchway Brook Roundabout in a southerly direction for a distance of 100 metres | 28 September – 6 December 2026 |
